

## **THE MAGIC PLANET PROJECT CALL FOR ONE- TO THREE-DAY RESIDENCIES AT MAGIC MEGEVE**

The Magic Collection Retreats intends to host international non-profit associations or foundations working in sustainability in Megève, for periods of one to three days.

Hospitality and services will be included in this package. Residence at the facility will entail the use of services according to availability. Board and lodging will be guaranteed.

Details of the call for applications will be published on [www.themagiccollection.com](http://www.themagiccollection.com) on the 17th October 2022. The application period will start on the 1st of December 2022 at 9.00 am and end on the 15th of January 2023 at noon.

### **Purpose**

In operating The Magic Planet Project, The Magic Collection Retreats aims to

- implement socially responsible practices;
- give back to local, national and international communities;
- support work in sustainability;
- offer non-profit associations and foundations a unique place to work, reflect and practice.

This call for applications is aimed at local, national and international associations or foundations with a social purpose, willing to stay for one to three days at Magic Megève and there discuss the theme proposed in their application with their working groups. Groups of participants must not exceed 10 persons. Larger groups may be discussed once an application is put forward.

Interested parties must have experience in the field of sustainability when responding to this call. The eventual allocation of the hospitality package will be nominal for each entity and no relationship will be established between Magic Megeve and the assignees of the hospitality package.

### **Documentation**

To participate in this call, applicants should send

- a copy of the completed and signed application form (Annex 1);
- a photocopy of an identity document of the legal representative and the organisation's statutes and articles of association;
- the curriculum vitae of their initiatives and projects, together with any links to presentations or websites, and/or printed material, photographs, catalogues, projects, videos (The Magic Collection Retreats will not be responsible for sending copyrighted material or infringement of other possible copyrights in the attachment of documents)

- a summary of the theme dealt with during the hosting days at Magic Megeve and of the programme of their stay.

Applicants may specify periods of preference over those indicated below. Please note that applicant preference is not binding for The Magic Collection Retreats, which will assign the periods as well as the number of days of hospitality, on the basis of its own organisation. Periods of the packages related to this notice are:

- 15th – 30th of April (period subject to change according to easter holiday dates)
- 15th – 30th of November (period subject to change according to christmas holiday & half term dates)

### **Rules of participation**

Applications must be sent pec to [csrprogram@themagiccollection.com](mailto:csrprogram@themagiccollection.com) by noon on the 15th of January 2023, under penalty of exclusion. If the application is sent by pec, the subject of the email include “the Magic Planet Project”. The application must be in pdf format and must be signed. The attached documentation must be sent in commonly used application formats (Microsoft Office or Open office). Applications that are incomplete or received after the deadline or do not comply with the indications will not be considered.

### **Allocation**

The selection of participants will be carried out by The Magic Collection Retreats team, who will allocate the hospitality packages at their sole discretion according to the following criteria

- curriculum vitae;
- quality of the project proposal;
- alignment with the theme of sustainability.

The list of hospitality period assignees will be published on the website of The Magic Collection Retreats on 15th of February 2023. On this same date, an email will be sent to the winning team, based on the address provided in the application form, as well as an indication of the assigned period for the stay and the regulations for use of the structure.

### **Privacy**

The material provided will be treated in accordance with privacy regulations. Only the names of those who have been awarded the contract will be indicated on the website, which is expressly authorised by signing the application form.
